Tax Assessment is calculated as follows:

| Beer                        | Table Wine (16.5% abv or less) | Wine (16.5-23.9% ABV) | Wine (over 24% ABV) |
|-----------------------------|--------------------------------|-----------------------|---------------------|
| 5 cents per 12 fluid ounces | 38 cents per liter             | \$2.42 per liter      | \$4.40 per liter    |
